HOW IT WORKS

BEACH VOLLEYBALL SEASON WORKS LIKE THIS; YOU, THE PLAYER, ORGANIZE 2 OR 4 PLAYERS TO FORM A SUMMER BEACH LEAGUE TEAM. YOUR TEAM WILL PLAY ONE NIGHT A WEEK FOR 8 WEEKS, WHICH INCLUDES A SINGLE ELIMINATION TOURNAMENT. GAMES BEGIN AT 6:00 SHARP! TUESDAY NIGHT QUADS LEAGUE IS CO-ED AND REQUIRES A MINIMUM OF 2 FEMALES ON THE COURT, MONDAY NIGHT CO-ED DOUBLES REQUIRES ONE FEMALE. MONDAY NIGHT DOUBLES, WEDNESDAY NIGHT, THURSDAY NIGHT AND FRIDAY NIGHT QUADS LEAGUES ARE OPEN AND CAN HAVE ALL FEMALE, MALE OR A MIX OF BOTH. JUST REMEMBER, BEACH VOLLEYBALL CAN TAKE A LOT OF ENERGY... THE SMALLER THE TEAM, THE MORE SAND YOU WILL NEED TO COVER TO BE COMPETITIVE. LEAGUES ARE ON A FIRST COME, FIRST SERVE BASIS. AMATEUR ATHLETIC WAIVER & RELEASE OF LIABILITY

In consideration of being allowed to participate in SPIKES, INC., athletics / sports leagues, programs and related activities, the undersigned;

1. Agree that prior to participating, they will inspect the facilities and the equipment used, and if they believe anything to be unsafe they will immediately advise their team captain or supervisor of such condition(s) and refuse to participate.
2. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions or negligence of others, the rules of play, or the condition of the premises or any equipment used. Further, that there may be other risk not known to us or not reasonably foreseeable at this time.
3. Assume all forgoing risk and accept personal responsibility for damages following such injury, permanent disability or death.
4. Release, waive, discharge and covenant not to sue SPIKES, INC., it's affiliated clubs, their respective administrators, directors, agents, coaches and or other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of the premises used to conduct the event, all of which hereinafter referred to as the "lessees", from any and all liability to each of the undersigned, his or her heirs and their next of kin for any claims, demands, losses or damages on the account of injury, including death or damage to property, caused in whole or in part by the negligence of the lessee or otherwise.
5. Agree to play according to the rules and regulations of SPIKES, INC. Summer Sand Volleyball Leagues and I realize that failing to do so may mean immediate dismissal from the league with fee refund.
